On further Enquiry, it appeared that the Number of Servants was inadequate to the necessary Service of the House, & that the Children, particularly the Girls, were frequently taken from their Learning to assist in Housework.

At the same Time M^{rs} Ann Brown & Miss Ann Brown gave Notice of their Intentions to retire from their Situations in the School.



At this Board Mrs. Marg^{ret} Brown attended & produced Testimonials of her good Character; when the Rule ⁱⁿ the Quarter Board Book (Page 19), declaring the Duty of a Schoolmistress was read to her: and she, on promising to fulfill it to the best of her Power, was engaged as Schoolmistress, at a Salary of Fifteen Pounds *per* Annum, over & besides being found (at the Expence of this Charity) with such Provisions as are usually procured for the Children & Servants (Tea & Sugar excepted, which she is to provide at her own Expence)

Mrs. Ann Brown then appeared, & said that she was sorry for the hasty Notice she had given to retire at a former Board: that she was desirous of being Assistant Teacher in future:— when the Board, in Consideration of her past Services, appointed her Assistant Teacher at the Salary of Fifteen Pounds *per* Annum as heretofore.

Ordered that the Master keep an Account of the Names of all the Children, Date of Admission, Date of their Birth & Baptism, or Age when admitted, Their respective Numbers in the School, their Parents Names & Occupations, Places of Residence, Time of Discharge, to whom disposed of & how, their respective Masters or Mistresses Residence & Trade.

The six Pieces of blue Woollen-cloth M^r Greenwood was requested to write for are ordered.

The Boys ordered to be put Apprentices are respectively bound to different Masters with the Approbation of their Friends and have left the School.

The Number of Children now remaining in the House is 227 Boys and 89 Girls.

The Scales, Weights, and Measures have been adjusted.

Very soon after the last Board, Circumstances came to the Knowledge of the Treasurer which in his Opinion required an entire Change of all the Servants. He, therefore thought it unnecessary to read the Order of that Board respecting Dame Brown, and this Board (after hearing the Treasurer's Report) being of the same Opinion and thinking it desirable to get Servants that have no Connections in the Town, do request M^r Park's will go amongst her Friends at Harwarden as soon as M^r Brown is well enough to attend to the Business and get them to assist her in procuring such Servants as she thinks will be able to execute the Business of the House to her Satisfaction.

Ordered that all the Keys be given up to M^r Park's when she returns from Harwarden.

Ordered that the Allowance of Flour to the Servants be discontinued except to Mr. John Brown, Mr. Mary Brown and Mary Hottiwell - and that in Lieu thereof each of the other Servants shall have one Pound $\frac{1}{2}$ Day of the same Bread that is made use for the Children.

Ordered that the Application of Mr. Harrison, Mr. Barrow, and Mr. Richardson, who supply the House with Milk, &c. for an Advance of one half-penny $\frac{1}{2}$ Gallon both on sweet and sour Milk, making the former $\frac{3}{4}$ $\frac{1}{2}$ Gallon, and the latter $\frac{1}{2}$ - be complied with; but it is required that each Person shall deliver it on a different Day to the other two, and that they give full Measure.

Ordered that the Treasurer request Mr. Woods to write to his Correspondent at Ulverstone for 50 lb. Weight of Blue Worsted - 25 lb. of Black, and 25 lb. of white as $\frac{1}{2}$ Samples.

respective Dresses as will put all the Children into decent Attire.

Ordered that sufficient temporary Assistance be procured to get these respective necessary Repairs effected as soon as possible.

Ordered that this Board meet every Friday Morning at 10 o'clock, till the Quarterly Board in March.

On Saturday Evening last, Nancy Powell & Mary Roberts (two of the Servants) got leave to go to visit their Friends: They did not return, however, till Sunday Morning, and had three Men locked up with them in the Kitchen at 12 o'clock that Night: A Bowl of Rice was also secreted by Powell, which it is supposed, was intended to be put into the Swilling Tub, as the Woman who purchased the Swillings had given her some Tea, &c.

Altho' there is not a Board the Trustees present ordered the Servants to be discharged immediately - paying them their Wages up to this Day and no longer.

Ordered also that the Practice of setting the Swillings
be discontinued, and that instead thereof, a Pig, or two be
occasionally purchased & fed for the Benefit of the
Hospital.

Desired the Treasurer would request the Rev^d Rob^t

A great Number of the Boys' Parents and Friends attended this Board in Order to lay Complaints against the Agent of the Pin-factory, most probably in Consequence of the Boys having in some Way sent them Information that Mr Meredith would be there. Upon their being heard however in the Presence of Mr Meredith, they were universally of so frivolous a Nature, that the Trustees found great Reason to reprimand the Conduct of all the Parents on the Occasion instead of redressing their trivial and idle Complaints of Abuse.

Agreeably to the intimation communicated by notice from the Treasurer, that Mr. James Meredith of Manchester Pin Manufacturer was desirous of meeting the Trustees for the purpose of making a new contract for the employment of the Children in that branch of business, he attended at this Board & proposed as the best way of removing all the difficulties & inconveniences which had been found to arise from the former contract to pay the Charity for the quantity of work done at the prices he paid to people he employed at Warrington, viz, 3^d per lb. for Middlings & 2^d for calking pins, he finding all Materials and impliments, & a Man to keep the Tools in order, and see that the work was well done, he also is willing to suffer all loss or case of waste, and if at any Time there should be a want of materials

On the Subject of the Pin factory being resumed the following Observations were ordered to be printed, and a copy thereof sent to each respective Trustee to consider of previous to the next quarterly Board, when the Treasurer will make a proposal for discontinuing that employment & reverting to the original plan of the Institution, viz that of instructing the Children only.

The idea of miring the Children brought up in the Hospital to labour, or to habits of industry, by employing them half their time in making pins, is very plausible, and the emolument arising from it, may be thought a strong inducement to continue it; but it is probable both these appearances are illusory, and if not contrary to the Rules of the Society, not strictly conformable to them, as the daily interruption to the Childrens' education, very

materially retards their progress in learning.

With respect to inuring them to labour, it is not to be supposed that end can be obtained by an employment that is not laborious, and habits of industry and application, especially as far as the mind is concerned, are more promoted by the Book than the Block, and is besides more healthy. As to emolument, it is true that Mr Meredith has paid £450 per Annum for a few years back, that is, for the labour of 100 Boys, and Buildings that would rent for £70 or ~~80~~ per annum, but he says he would not give more than £400 for a renewal of the contract, as he has lost money by it lately; for the Children, it seems, did more work in the two first years, than they have ever done since. The plan which has been pursued since Christmas, would not produce so much as £400 per Annum, though 100 Boys should be sent into the Factory, which cannot be done out of the present compliment. If then £70 be deducted for the rent of the premises, and £30 for deficiency of number, £300 per annum is the most that can be considered as likely to arise from the labour of the Children.

That is a large sum, and ought not to be relinquished without mature deliberation, but the impression naturally excited by such a proposal is not to absorb our whole attention; the primary object of the Institution, viz. the feeding, clothing, educating and bringing up the children in the principles of

Religion and Morality, thereby making them more useful members of society, and fitting them for many situations either in the service of the Merchant or Mechanic, which they would not otherwise be capable of, is at least of equal importance, and of course demands an equal share of consideration.

The present Masters declare that they cannot expect to do any credit to themselves or to the School, whilst the Pin factory is continued, that it is a continual source of uneasiness and discontent, not only to themselves, but to the Children and to their Parents, and that it is made a place of interview for the latter, on which occasions many improprieties are committed, over which they can have no controul, as they are done without their knowledge; they have however been informed of practices that are so entirely at variance with all the objects of the Institution, that it is thought they would be more completely attained in three years, if that impediment was removed, than they now are in six, and at less expence, because of the shorter length of Time; for the earnings of any individual in the whole six years, will not amount to half the expence of three years extra maintenance: The benefits would in that case, be extended to nearly twice the number of children, and twice the number of families; which is more desirable than doing a greater and more continued service to a few, by maintaining their children for three years longer

than is necessary. It therefore appears, that although a clear income of £300 per Annum, should arise to the charity, by the labour of the boys, it is far from being again, that the benefits of the School may be more widely extended if it be given up, and the children retained only three, or from three to four years.

Such a regulation would not be repugnant to the rules, which only forbids the Trustees taking any child before he be eight years old, or keeping him after he has attained fourteen; as few, however, are fit to be bound apprentice at an earlier age, it follows, that upon this plan, no child can be admitted before he be ten years old; to which it may be objected, that the Parents would be oppressed with the maintenance of their children two years longer than they now are, before they would be admissible, and there would be danger of their being corrupted in that time. It is to be feared that it might sometimes happen so, to some children of the description that have generally been admitted; but are not such more fit objects of the Work-House than the Blue Coat Hospital? and would not the Town of Liverpool always furnish as many children annually as the Hospital can accommodate, or its income support, who yet are objects of such a charity, although their parents have by their exertions and commendable industry, lived in some decency, and kept their children at School until they have attained ten years? such would seem to be

intitled to a priority of those advantages of education afforded there, and the feelings of humanity are perhaps carried too far, when they operate so as to promote the child of poverty and wretchedness, merely because it happens to be in that forlorn situation, in preference to those just mentioned, some of whose parents may perhaps have seen better days.

The advantages of selecting the children from other schools, which is the practice of the Blue Coat Hospital of Chester, would be many and great; the conduct of the Parents, as well as the abilities of the children, could be ascertained, and where the talent of acquiring learning showed itself, it might be cultivated to some effect as in the days of the late Mr. Houghton when Navigation was taught, and several of the children became Masters of Ships. The credit to the School would then revert to its former renown, and both Masters and Parents would have more satisfaction than at present. If in addition to the above, the admission was limited to once a year, the attraction would be still more complete, as many smaller advantages would arise from it, which would contribute most essentially to the regularity of the Family, and leave three quarter

days for the transacting of other business;
and it is but reasonable, that those who are
admitted to the privileges of such an Institution,
should submit to receive them under such restric-
tions, as may be most conducive to the good
government and convenience of the House.

After so much has been said upon the
subject, it may all be summed up in this,
that without militating against the rules of the
Institution, the intention of its Founders may
be more completely obtained without the
Orphan Asylum than with it, at less expence too,
and with infinitely more satisfaction to all
parties; and being effected in half the time,
more families would be served, and the benefits
extended to a greater number of Children.
